

## Minutes of the Annual General Council Meeting of Hockey Jammu & Kashmir held on 10th November 2024 at Hotel Clarks Inn, Jammu.

- The Annual General Council meeting of Hockey J&K was held on 10th November 2024 at Hotel Clarks Inn, Jammu. The meeting was chaired by Sh.Rajinder Koul, Senior Vice-President of Hockey Jammu and Kashmir.
- The General Secretary of Hockey J&K conducted the proceedings of the meeting and thanked all the members and office bearers for attending the Annual General Meeting, especially the members from Kashmir division and Mr Yudhvir Singh (Observer) from J&K Olympic Association .
- All the club members present in the meeting introduced themselves one by one in a very disciplined manner.

All the points of agenda were discussed in detail as under:

### Agenda Point 1 : Confirmation of minutes of previous meetings.

- The General Secretary, Hockey Jammu and Kashmir submitted the details of previous executive board meetings.
- Sh. Amarjeet Singh proposed the resolution for approval of previous minutes of meetings and Ms. Asima Ali seconded it.
- After a brief discussion, it was approved and confirmed by the house in a voice vote.

### Agenda point 2 : Consideration and passing of auditors statement of accounts.

- Sh. Ishan Sharma, Treasurer of Hockey Jammu and Kashmir presented the auditors report for the year 2023-24 with details of cash as per the statement.
- It was proposed by Sh.Tejinder Singh and Sh. Daljeet Singh seconded it.
- After a brief discussion, it was passed by a voice vote.

### Agenda Point 3 : Appointment of auditors and fixing their remuneration.

- Mr.Talib Hussain proposed that we should continue with M/S Gupta Sharma & Associates as auditors for Hockey Jammu and Kashmir and Sh. Rajinder Singh seconded it.
- It was approved by voice vote.

**Agenda Point 4:** Consideration and adoption of the General Secretary's annual report.

- Detail of activities conducted during the year was presented by the General Secretary about various national events organised by Hockey India, local activities at the Kashmir division and in the Jammu Division, details of tournaments organised by different organisations under the aegis of Hockey J&K and participation in National Championships.
- It was unanimously approved by the House.

**Agenda Point 5:** Consideration of the annual hockey calendar.

- All the district units were requested to complete the activities of their respective districts at the earliest and submit the report to Hockey Jammu and Kashmir.

**Agenda point 6 :** Pending affiliation fees

- All the affiliated clubs were directed to deposit their Annual fees to Hockey Jammu and Kashmir, as the fee of some clubs was still pending. Clubs were requested to deposit the same by or before 31st December 2024 failing which action will be taken as per the constitution of Hockey Jammu and Kashmir.

**Agenda point 7 :** Correction(s) in the constitution of Hockey J&K (If any).

- Discussion was held regarding the correction of some grammatical and printing errors in the constitution of Hockey J&K.

**Agenda point 8 :** Any other matter with the permission of the chair.

- The General Secretary informed the house that president Mr Gurdeep Singh Sangral deceived the association by floating letters to Sports Council & ADGP (J&K police) that all the correspondence on behalf of Hockey J&K will be done by the president only and no other member of the society, which is against the constitution of Hockey Jammu and Kashmir. Due to this, the senior men's national team selected by Hockey J&K was refused screening by Sports Council.
- The General Secretary informed the house that Mr Gurdeep Singh Sangral made a new team overnight consisting of players who neither attended the selection trials nor the

coaching camp, So how could these players become eligible for screening by J&K Sports Council?

- The notice for AGM was issued after due consultation with the President, Mr Gurdeep Singh Sangral, and was initially scheduled to be held in Srinagar on 10-11-2024. Due to security concerns, it was decided that the AGM would now be held in Jammu after consulting with the president. However, on 08-11-2024 at 11:00 PM, prior to the AGM, Gurdeep Singh Sangral issued a notice for deferment of AGM on a fake letter pad and without any reference number.

So, keeping all these in consideration that Mr Gurdeep Singh Sangral is working against the constitution and the aims and objectives of Hockey J&K, the executive board members decided to bring a no-confidence motion against the president. It was approved by 2/3<sup>rd</sup> members in the EB board meeting and it was later approved by 2/3<sup>rd</sup> members in the AGM also.

For working against the objectives of Hockey J&K, and the undemocratic attitude, Mr Gurdeep Singh Sangral was removed from the post of the president and the house decided that Senior Vice President, Sh. Rajinder Koul be appointed as the working president of Hockey Jammu and Kashmir with immediate effect till next elections. It was proposed by Ms Asma Ali and seconded by Tajinder Singh.

It was also decided in the meeting that some clubs that were filing false cases against the Hockey Jammu and Kashmir in the court were demoted to provisional affiliations.

Also it was discussed in the meeting that some of the hockey clubs have requested to get themselves affiliated with Hockey Jammu and Kashmir and a 3-member committee to be formed for providing a provision affiliation to these clubs.

It was decided regarding formation of District Committee for every district, which will monitor the activity and tournaments in their respective districts.
