

## **Minutes of Annual General Council meeting of Hockey J&K held on 10th December 2023 at hotel Vivanta , Jammu City Centre , Jammu.**

Annual General Council meeting of Hockey J&K was held on 10th December 2023 at hotel Vivanta , Jammu City Centre , Jammu.

The meeting was presided by Sh.Rajinder Koul, Senior vice President Hockey Jammu and Kashmir as due to Some health issue , President Hockey J&K Sh.Gurdeep Singh Sangral was unable to attend the AGM.

Before the start of the meeting, a two minutes silence was observed on the sad demise of Madam Mohinder kour ( Former General Secretary Hockey J&k & Former Executive Member Hockey India ), Sheikh Mohd.Maqbool ( Founder member Hockey J&K and Former senior vice president Hockey J&K ) and Gurpreet Singh (National hockey player).

General Secretary Hockey J &K who was conducting the proceedings of the meeting thanked all the members and office bearers for attending the Annual General Council Meeting especially the members from Kashmir division ,Poonch , Rajouri,Kathua & Udhampur .

All the club members present in the meeting introduced themselves one by one in a very disciplined manner.

All the points of agenda where discussed in detail as under:

### **Agenda Point 1 :** Confirmation of minutes of previous meetings.

In the meeting , resignation of members which were accepted by the executive committee in previous executive board meetings and new members which were appointed as per the constitution of Hockey J&K to fill the vacant posts was detailed.

General Secretary Hockey Jammu and Kashmir submitted the detail of previous executive board meetings.

Sh.Vinod Singh proposed the resolution for approval of previous minutes of meetings and Sh.Jaspreet Singh seconded it.

After a brief discussion it was approved and confirmed by the house in a voice vote..

**Agenda point 2 :** Consideration and passing of auditors statement of accounts.

Sh. Ishan Sharma , Treasurer Hockey Jammu and Kashmir presented the auditors report for the year 2022-23 with detail of cash as per the statement.

It was first proposed by Sh.Raja Yaqoof and seconded by Sh. Khalid Bashir

After a brief discussed, it was passed by a voice vote.

**Agenda Point 3 :** Appointment of auditors and fixing their remuneration.

Mr.Talib Hussain proposed that we should continue with **M/S Gupta Sharma & Associates** as auditors for Hockey Jammu and Kashmir and it was seconded by Sh.Daljeet Singh.

After that it was approved by voice vote.

**Agenda Point 4.:** Consideration and adaptation of general secretary annual report.

Detail of activities conducted during the year was presented by the General Secretary which included participation of JKUT teams in various national events organised by Hockey India , local activities at Kashmir division and in Jammu Division , detail of some tournaments organised by different organisations under the aegis of Hockey J&K .

Finally activity report was approved by house by voice vote.

General Secretary assured all the members for full support in future and requested for speed up the pending registration process of players in hockey India portal , as unregistered player is not allowed to participate in any national event.

**Agenda Point 5:** Consideration of annual hockey calendar

All the district units were requested to complete the activities of their respective districts at the earliest and submit the report to Hockey Jammu and Kashmir.

**Agenda point 6 :** Pending affiliation fees

All the affiliated club were directed to deposit Annual fees to Hockey Jammu and Kashmir as fees of some clubs is still pending .Clubs were requested to deposit the same up to 31st December 2023 failing which action will be taken as per the constitution of Hockey Jammu and Kashmir.

**Agenda point 7 :** JKUT Hockey championship at Jammu.

Discussion was held regarding JKUT Hockey championship ,which was scheduled to be held at Srinagar in the month of September 2023 but due to some problem it was not possible to conduct the said activity.


All the members were in the opinion that it should be organised at Jammu from 10th February 2023 in which all the districts would participate.

General Secretary was directed to take up the matter with sports council for release of funds regarding JKUT Championship.

**Agenda point 8** : other matters

- To circulate annual calendar of activities for the Year 2024- 25 in April so that district units can start preparations as suggested by Shri Raja Yaqoof .
- Identify Umpires in all districts and special clinics , and workshops should be organised as suggested by Jaspreet Singh.
- Mr Sayed Talib suggested that Hockey J&K should organise hockey tournaments at school level to extract more and more talent
- All the members suggested to get the appointment with Lieutenant Governor and discuss regarding upliftment of this game with Lieutenant governor in detail and also raising of departmental hockey teams as in football.
- Also members suggested that General Secy should take up the matter with sports council authorities for installation of digital score board at KK Hockey Stadium Jammu as well as at Polo Ground Astro Turf Srinagar along with office and store facilities for the association .
- Meeting concluded with a vote of thanks from Sh.Rajinder Koul ji (Sr.Vice President Hockey J&K).
