1. The present petition has been filed by the petitioner being aggrieved by the alleged contravention of the order dated 17.01.2025 passed by this Court in CM APPL. 2825/2025 of W.P(C) 613/2025. The said order reads as under:

"8. At this stage, learned counsel for the petitioner requests for a limited relief viz. that the links of the Executive Board Meeting of the respondent no.1 be provided to the petitioner to enable her to attend and participate in the meetings in her capacity as the elected Vice President.

9. After some hearing, it is agreed that the requisite link shall be provided to the petitioner to enable her to participate in all Executive Board Meetings that may be held. However, learned counsel for the petitioner undertakes, on instructions, that the link will not be shared by the petitioner with any third party nor will the petitioner allow any third party to be privy to the deliberations that take place in the meeting."

2. It is the case of the petitioner that the respondents in wilful

disobedience of the aforesaid order have neither sent notice/s nor meeting link/s to the petitioner.

3. Issue notice.
4. Learned counsel, as aforesaid, accept notice on behalf of the respondents.
5. Let reply be filed by the respondents before the next date of hearing.
6. List on 06.08.2025.
7. After some hearing, it is stated by the learned senior counsel for the petitioner that the directions contained in the interim order dated 17.01.2025 passed in CM APPL.2825/2025 of W.P.(C) 613/2025 shall be complied with and links shall be provided to the petitioner for the purpose of participation in the meetings of the Executive Board of Hockey India. Further any decision/s that were taken in any previous Executive Board meetings (for which links were not provided to the petitioner) shall be put in abeyance, till the same is once again considered by the Executive Board in the presence of the petitioner.
